**Basic Services of Funeral Director, Staff and Overhead ..... \$1,495.00**

Our services include: conducting the arrangements conference; planning the funeral; consulting with family and clergy; shelter of remains; preparing and filling of necessary notices; obtaining necessary authorizations and permits; coordinating with the cemetery, crematory, or other third parties. In addition, this fee includes a proportionate share of our basic overhead costs. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains. Also included is the initial shelter of remains to five days.)

**Transfer of Remains to the Funeral Home ..... \$425.00**

Within a 30 mile radius of a Deercreek facility. Beyond this radius we charge \$1.00 per mile.

**Refrigeration..... \$495.00**

As required by Health & Safety Code in refrigeration of unembalmed remains (up to five days), additional charge may apply for extended holding. This \$495.00 is part of our basic services of funeral director fee (IE Included) for all bodies from date we shelter the body for up to one week, Additional shelter, if required, per day is \$75.00 each additional day.

**Funeral or Memorial Service At Your Place Of Worship - Delivery & Set-up.....\$295.00\***

Coordination with Clergy, musicians, chapel secured, someone to receive guest and flowers, necessary equipment to hold casket.

Time under three hours, if over Add \$100.00

After 5:00 PM or Saturdays .....\$500.00

Visitation at your place of worship .....\$400.00

**Hearse to Three Hours (Each Additional 60 Minutes Initiated \$125.00 Per Hour) ..... \$495.00**

Alameda / Contra Costa County. Under 75 miles round trip. Add \$2.00 per mile if over 75 miles.

**Receiving Remains From Another Funeral Home ..... \$1,395.00**

Our charges includes: basic services of funeral director and staff; a proportionate share of overhead costs; receiving remains; and transportation to local cemetery. (Without ceremony by van)

**Shipping Remains to Another Funeral Home..... \$2,195.00**

Our charges includes: basic services of funeral director and staff; a proportionate share of overhead costs; transfer of remains; embalming and transportation to local airport.

**Witness I.D.**..... **\$300.00**

At our holding facility (Utilitarian setting, without chapel, body preparation). During normal business hours - to one hour.

**Direct Cremation** .....**\$895.00 - \$1,995.00 \*\*\***

Our charge for a direct cremation (without ceremony) includes: basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; transportation to crematory; necessary authorizations; and cremation if relevant.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are a fiberboard container or an unfinished wood base box.
